Whereas, the adoption of this 2024 budget for the Wayland Free Library requires a tax levy increase that exceeds the tax cap imposed by state law a outlined in General Municipal Law Section 3-c adopted in 2011; and

Whereas, General Municipal Law Section 3-c expressly permits the library board to override the tax limit by a resolution approved by a vote of sixty percent of qualified board members; now therefore be it

Resolved, that the Board of Trustees of the WAYLAND FREE LIBRARY voted and approved to exceed the tax levy limit for 2024 by at least sixty percent of the Board of Trustees as required by law on March 21, 2024.

<u>Adoption of 2024 Budget</u> – Motion to adopt proposed budget for 2024 to include approved wage increases and tax levy increase.
